## UIAA CONDITIONS FOR INTERNATIONAL LICENSES

### 1. Obligations of Competitors

By applying for an International License the competitor acknowledges and accepts the rules and anti doping policy and procedure of UIAA-ICICC and commits him or herself to act according to these rules and procedures.

#### 1.1 In connection with anti-doping procedures the competitor:

- Refrains from using drugs and other prohibited substances or encouraging others to make use of drugs or other prohibited substances;

- Expressly consents to submit to all methods of testing (blood, urine, gases, etc.) and any medical, clinical, or biological testing conducted either out of competition or at a competition by the Member Association, ICICC-UIAA, the World Anti Doping Agency (WADA) and/or their appointed testing authority for the purpose of revealing if a prohibited substance is present in his or her body or to reveal the possible use of prohibited substances or methods;

- Expressly acknowledges the right of WADA to perform out-of-competition testes for UIAA – ICICC.

- For the purpose of out of competition testing undertakes to inform his or her Member Association in advance of the places he or she intends to train;

- Expressly acknowledges the right of UIAA to join as a party to any disciplinary proceedings or arbitration in connection with alleged doping offences.

#### 1.2 Competitors applying for an International License also acknowledge and accept that:

- In UIAA-ICICC Ice Climbing Competitions they understand and abide by the regulations and rules of the sport and observe the principles of good sportsmanship;

- Accept, subject to the official appeal procedure, the decisions of the official judges without question or protestation and exercise self-restraint at all times;

- Treat other competitors, officials and others involved in the practice of the sport with full and due respect at all times, both during and outside a competition.

- Safety is a primary concern at Ice Climbing Competitions but as with all the other forms of climbing there is a danger of personal injury or death;

- Holders of International Licenses accept the risks of participation and are responsible for their own actions which should take account of relevant circumstances such as changing weather and snow/ice conditions.

- To take part in Ice Climbing competitions it is necessary to be medically fit and have valid liability and accident insurance.

### 2. Obligations of UIAA Member Associations

A Member Association whose competitors apply for an International License undertakes:

- To ensure competitors (and or the parents or legal guardians of those under 18 years) are aware of, understand and accept their obligations and the risks and responsibilities of taking part in ice climbing competitions;

- To maintain an up-to-date list of contact details and addresses of holders of International Licenses and information on their training venues and to make these details available to

UIAA-ICICC and WADA for the purpose of out of competition testing (N.B. the contact details of the Member Association are not acceptable as the contact details of the competitor);

- to **immediately** inform UIAA-ICICC of any positive result of a doping test and commence a disciplinary proceeding against any competitor who has been tested positive for doping and to inform UIAA-ICICC about such proceedings;

- that all applicants for International Licenses have liability and accident insurance cover for ice climbing competitions and are medically fit to take part.

## NOTES ON UIAA-ICICC INTERNATIONAL LICENSE

### 1. Objective:

To allow high-level competitors to participate in official international events.

### 2. Obtaining the license:

The Member Association must contact the UIAA office in Bern to obtain the International License or download it from the website so that their competitors can take part in all official events of the annual UIAA calendar. Forms shall be sent **by Post, by E-mail or by Fax** duly dated and undersigned by Federation's Officer in charge and the Competitor. Forms without the seal and the signature of the applying Federation and of the competitors **shall not** be taken into consideration.

### 3. Format of the international license:

The international license is this document duly signed and sent to the UIAA Office in Bern. The competitor will then have his/her name on a list made public for every competition organiser to have immediate access to. Validity of each licence expires at the end of the respective calendar year.

### 4. Price:

The international license is sold by the UIAA to the Member Association. The price of the UIAA-ICICC international license for the 2010 season is **EUR 50 for adults** and **EUR 25 for Youth Competitors**. The Member Association is responsible for eventually selling the UIAA international license to the competitor. The fee payment must be received by the UIAA BEFORE the Competition Event. Payment can be either by bank transfer or you can request the online Paypal payment facility, which the UIAA office will send through e-mail. Licence applications received less than 3 working days before the relevant Competition will be subject to a higher Express charge of EUR 150.

### 5. Application:

All competitors (including youth categories competitors) competing in International Climbing competitions are requested to be in possession of an International Licence issued by the UIAA-ICICC.

### 6. Authority:

An International License is compulsory for all official events. Those competitors for whom their belonging Federations have not applied for an International License, will **NOT** be allowed to compete in UIAA approved events.

### 7. Data Protection

The UIAA-ICICC will only use the data from International License for the purpose of anti doping procedures, events organisation and transmitting information on Ice climbing.
