Subsequent Registration per additional MQL qualification	100	Applies where MF is already accredited for at least one MQL and registers an additional discipline
Admin Revalidation (Yr 4)	300	Desk review of updated programme documentation.
In-Person Reval. (Yr 8)	0	Same as initial validation (see Inspection Fees). Reg. fee waived.

Inspection Day	Admin Fee	Scope
First day of inspection	100 CHF/day	1 hr admin: coordination, setup, invoicing prep.
Each subsequent day	50 CHF/day	Reduced rate: ongoing coordination & expense clarifications.
